Redress manager 2010 is built on and includes the Mortgage Fundamentals® system used by many financial service companies including banks, building societies, life assurances companies and those companies providing support and guidance to financial services (including FSCS and FOS).

System abilities

Payment protection insurance (PS 10/12 compliant) - Single premium added to loan / mortgage and monthly premiums allowed for (including credit cards); various scenarios including missing premiums, waiver of conditions, claim periods. User and system provided rates for interest rollups (simple / compound).

Investments - comparison of product sold versus equivalent product / fund / indices or savings based on savings / bank of England rates or alternate rates.

Pensions - calculations based on comparing actual scenario (e.g. transfer to different policy or SIPP) versus what would have been if left. This includes interest roll-ups based on simple / compound interest and income payments.

Mortgage, loan capabilities - reconstruct the original loan and compare various scenarios including incorrect rates, method of repayment, arrears, overpayments etc.

Endowments - calculate redress based on a variety of FOS scenario's including sold into retirement, partial conversions, change of lender, variety of other mortgage scenario's (RU89)

Road map

Over the years we have constantly improved our product range, ensuring each release brings with it more features. The latest releases have seen the inclusion of a new adjustment load facility and rate calculator.

- Backward compatible - can still run old cases
- Platform compatible - testing on both old and new versions of windows, like Windows NT, XP, Vista, 2003, 2008 and Windows 7
- Regression testing - we literally run millions of calculation checks on each new release
- Usability - ensuring existing customers will be able to use the system without additional training (although we strongly recommend training every 9-12 months, especially on the new features)

Behind the scenes we have been working on a new version of the calculation engine that is significantly faster than our existing engine, whilst including all the knowledge we have gained over the last 15+ years.

The new engine will address individual complaint areas and power a new generation of sophisticated tools.
